Source Water Internship with the Coalition for the Upper South Platte

Thank you for your interest in working with CUSP as an intern! We value your unique perspective and skills and appreciate your personal interest in natural resource management. The following provides a general outline of the Upper South Platte Watershed Source Water Assistant Internship, but individual experiences can be modified based on an intern's skills, interests, and schedule.

Job Title: Upper South Platte Watershed Source Water Assistant

Job Description: The Upper South Platte Watershed Source Water Assistant will begin implementing the best management practices outlined in Denver Water's Upper South Platte Watershed Source Water Protection Plan. The plan was developed as part of a collaborative process convened by Denver Water, facilitated by CUSP, and funded by the Colorado Department of Public Health and Environment through the Colorado Source Water Assessment and Protection program. The planning process and final plan are designed to provide municipal water providers and public consumers with information about drinking water, as well as providing a way for water providers and community members to get involved in protecting the quality of their drinking water. The program encourages community-based protection and preventive management strategies to ensure public drinking water resources are kept safe from future contamination. With the planning phase nearing completion, implementation of the plan's best management practices is now beginning. The Upper South Platte Watershed Source Water Assistant will work on projects to protect the water quality of the Upper South Platte Watershed. Projects may include, but are not limited to:

- Developing educational and reference materials for professionals and the public on topics such as septic system best practices, agricultural management, road maintenance, hazardous spills response, forest health, mining, and erosion mitigation as they relate to protecting water quality
- Creating inventories of existing resources, such as spill kit availability for hazardous spill response and funding sources for landowners to make water quality improvements on their property
- Connecting residents in the Upper South Platte Watershed with existing resources for protecting water quality in their area
- Coordinating with other organizations to develop or disseminate resources and plan projects
- Attending conference call meetings with the larger source water protection team
- Other source water projects, as assigned

Learning Goals

- Understand how stakeholders can work together to protect water quality and promote watershed health
- Gain experience developing watershed health resources and tailoring education and outreach materials to specific audiences
- Learn how to effectively work within communities to improve awareness and action around natural resources issues
